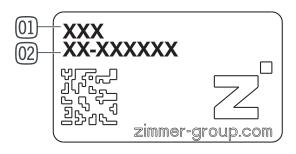

# 6 Functional description

The products are designed to be media exchangers.

The compact design reduces the torque loads for the handling system to a minimum.

The product avoids interference contours and thus prevents cable breaks, damage or tears caused by exposed wires.

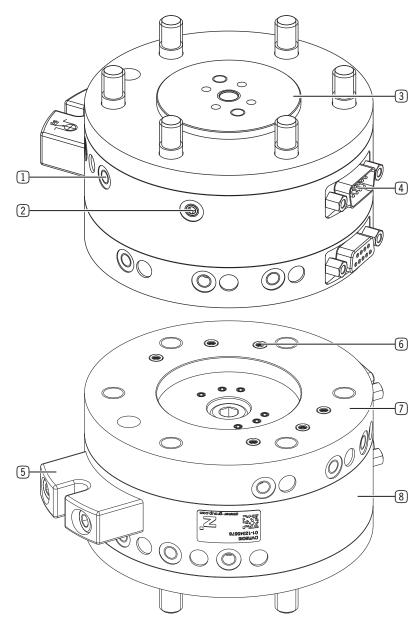
All currents from fine currents up to 250 V and a maximum of 6 A can be transmitted reliably.

Inside, the contacts on the slip ring allow for high flexibility in electrical transmission.

The housing acts as a stator by means of the torque support arm. The energy/media to be transferred is brought in here. The robot flange and the connecting flange on the tool are the rotating elements.

The structural design of the connecting flange is based on the specifications from DIN EN ISO 9409-1.

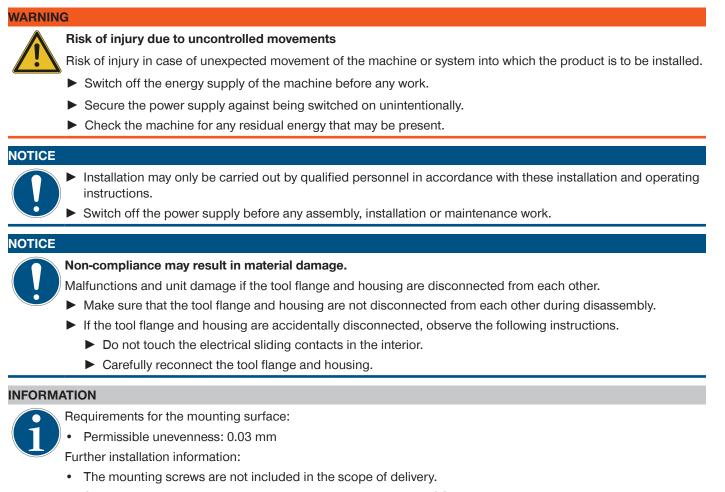

# 9 Transportation/storage/preservation

- ► Transport and storage of the product must be done only with the original packaging.
- If the product has already been installed on the superordinate machine unit, care must be taken during transport to ensure that no unexpected movements can occur.
  - Before commissioning the product and after transport, check all power and communication connections as well as all mechanical connections.
- ▶ If the product is stored for an extended period, the following points are to be observed:
  - ► Keep the storage location as dust-free and dry as possible.
  - ► Avoid temperature fluctuations/observe and adhere to the temperature range.
  - ► Avoid wind/drafts/water condensation formation.
  - Cover the product with a weatherproof, tear-resistant foil to prevent dust.
  - ▶ Pack the product and do not expose it to direct sunlight during storage.
- Clean all components. There must be no soiling left on the components.
- Visually inspect all components.
- Remove all foreign substances.
- Properly remove potential corrosion spots.
- Close electrical connections using suitable covers.



#### **10 Installation**



- Strength class of the mounting screws is at least 8.8 (DIN EN ISO 4762)
- · Screw-in depth in accordance with DIN EN ISO 9409-1
- Observe the tightening torque of the mounting screws.
- Verify the permitted load capacity of the required screw connections in accordance with VDI 2230.

# 10.1 Installing the product

When selecting the installation size and design of the product, the type of connecting flange on the robot in accordance with DIN EN ISO 9409-1 and the functions to be implemented on the tool are the deciding factors.

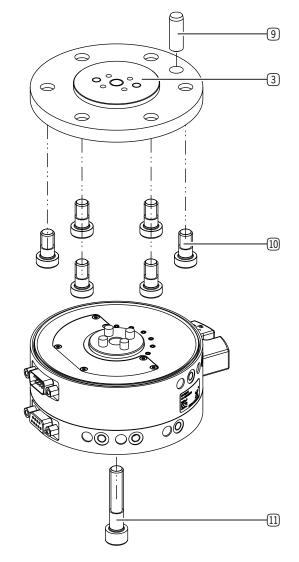

The product is installed between the robot flange and the tool. Installation begins on the robot flange. The tool or tool changer can then be installed on the product.

- Remove the central screw.
- Remove the robot-side connecting flange.
- Insert the straight pin into the designated fit on the robot-side connecting flange.
- Position the robot-side connecting flange onto the robot flange by using the straight pin.
- Install the robot-side connecting flange onto the robot flange by using the mounting screws.
- Reinstall the housing onto the robot-side connecting flange by using the central screw.

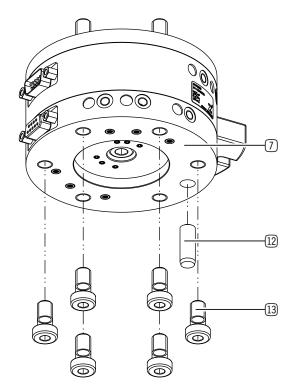


- 3 Connecting flange on the robot

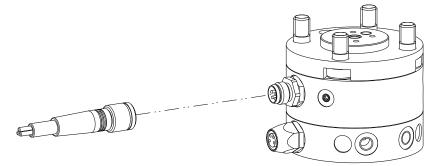

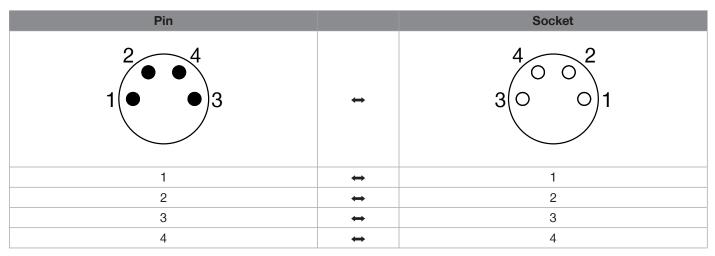

#### 10.2.2 Installing the pneumatic system

#### INFORMATION



The number of integrated air transmitters varies within the series.

▶ Insert the screw fittings into the provided connections.

In addition, there is the option of a hoseless pneumatic feed-through to the front of the tool flange. If this connection is used, the outputs on the outer edge of the tool flange must be sealed.

The assignment of the inputs and outputs can be identified by numbering. Labels for numbering are included in the scope of delivery.

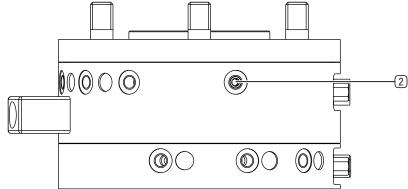
- 6 Hoseless air connection to the tool changer

#### 10.4 Attaching the torque support arm



#### Non-compliance may result in material damage.

The torque support arm is designed so that lateral torques are not applied to the middle part with floating bearing.Implement the torque support arm as shown.

Exchanging the standard torque support arm for a 2-point screw fitting in the middle part may damage the seals and the inner electric slip ring system.

#### INFORMATION



The pin must be manufactured according to DIN ISO 2768 - fH.

Calculate the pin diameter for the torque support arm using the dimensions from the dimensional drawing on the data sheet.

- Arrange the pin of the torque support arm parallel to the turning axis or casing surface of the product.
  - Maintain a parallelism tolerance of 0.1 mm.

# **11 Maintenance**

- Continuous operation with sealing air and its quality

Maintenance-free operation of the product is guaranteed for up to 10 million cycles.

The maintenance interval may be shortened under the following circumstances:

- Dirty environment
- Improper use and use that does not comply with the power specifications.
- Ambient temperature is too high.
- Even though the product is maintenance-free as mentioned above, perform a regular visual inspection to check for any corrosion, damage or contamination.
- ► Have maintenance work be performed by Zimmer Customer Service whenever possible.
- ⇒ Dismantling and reassembling the product without authorization may result in complications, as special installation equipment is required in some cases. Zimmer GmbH accepts no liability for any resulting malfunctions or damage.
