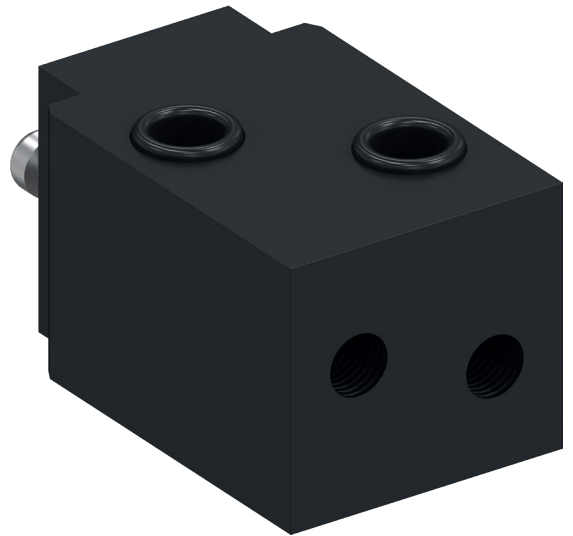
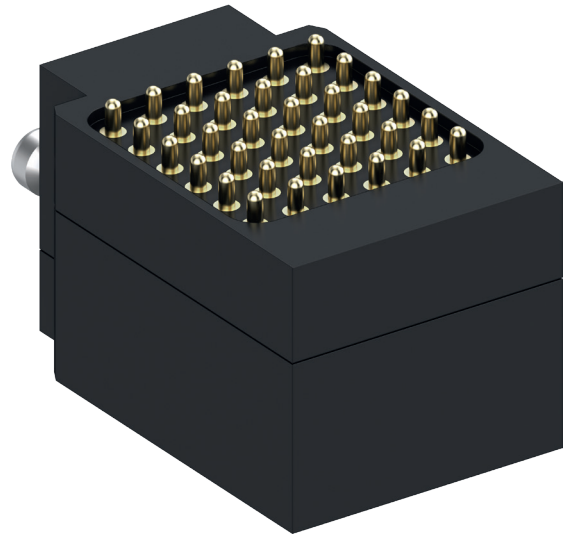

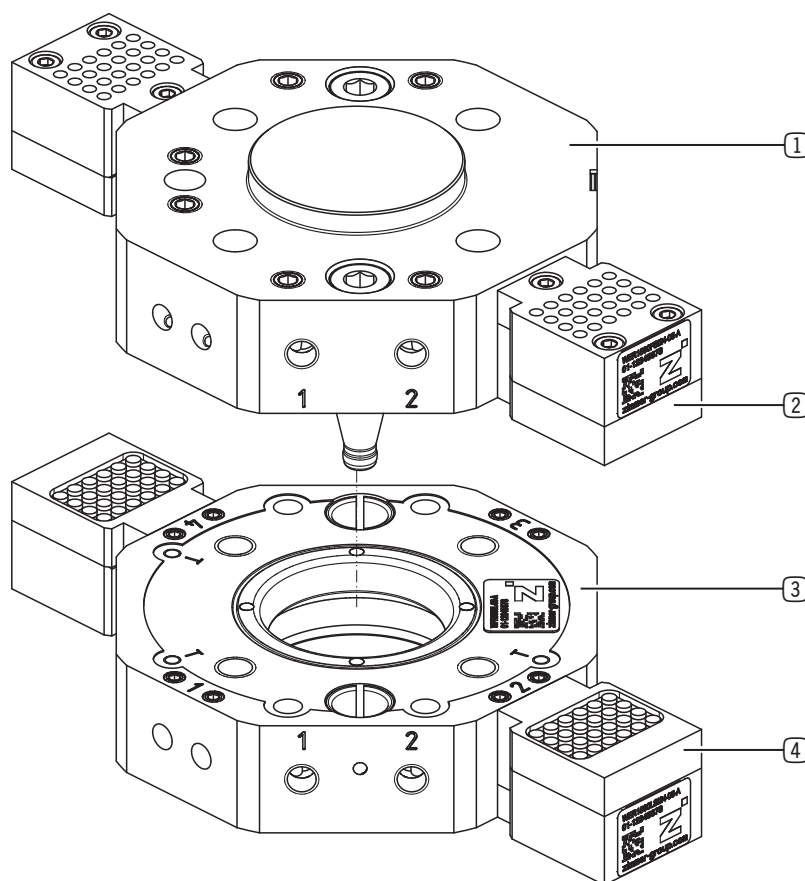

The stationary part and loose part can be differentiated by the identifier on the type plate:

- Stationary part: WERxxxxF
- Loose part: WERxxxxL

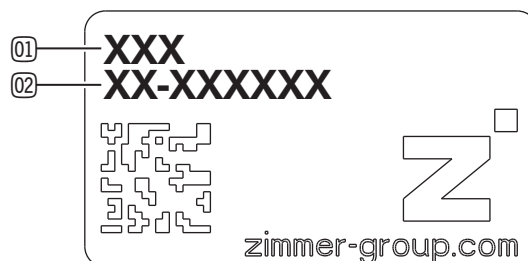
Example: WPR5050 with WER1500xSI24-05-A

The products transfer media from the robot to the tool.

Depending on the product variant, they are suitable for the transfer of compressed air and electrical energy.

Electrical products that have the hot plug function allow coupling or decoupling of energized fixed and loose parts.

9 Transportation/storage/preservation

- Transport and storage of the product must be done only with the original packaging.
- If the product has already been installed on the superordinate machine unit, care must be taken during transport to ensure that no unexpected movements can occur.
 - Before commissioning the product and after transport, check all power and communication connections as well as all mechanical connections.
- If the product is stored for an extended period, the following points are to be observed:
 - Keep the storage location as dust-free and dry as possible.
 - Avoid temperature fluctuations.
 - Avoid wind/drafts/water condensation formation.
 - Pack the product and do not expose it to direct sunlight during storage.
- Clean all components. There must be no soiling left on the components.
- Visually inspect all components.
- Remove all foreign substances.
- Properly remove potential corrosion spots.
- Close electrical connections using suitable covers.

10 Installation

DANGER



Potentially life-threatening hazard due to electrical voltage

- ▶ Shut off the electrical energy supply before decoupling and in the decoupled state if the products do not have the hot plug function.

Risk of injury due to uncontrolled movements

Risk of injury in case of unexpected movement of the machine or system into which the product is to be installed.

- ▶ Switch off the energy supply of the machine before any work.
- ▶ Secure the power supply against being switched on unintentionally.
- ▶ Check the machine for any residual energy that may be present.

Risk of injury from crushing

There is a risk of crushing injuries during coupling.

Only specific product variants may be decoupled while connected to the energy supply.

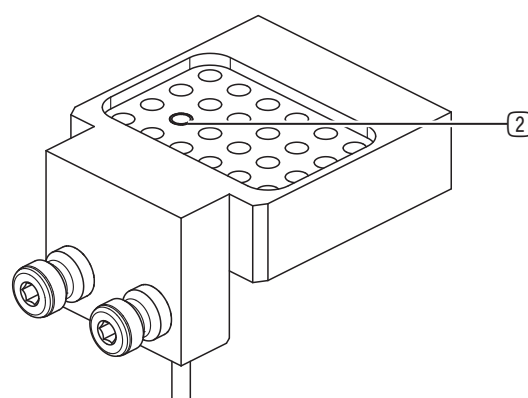
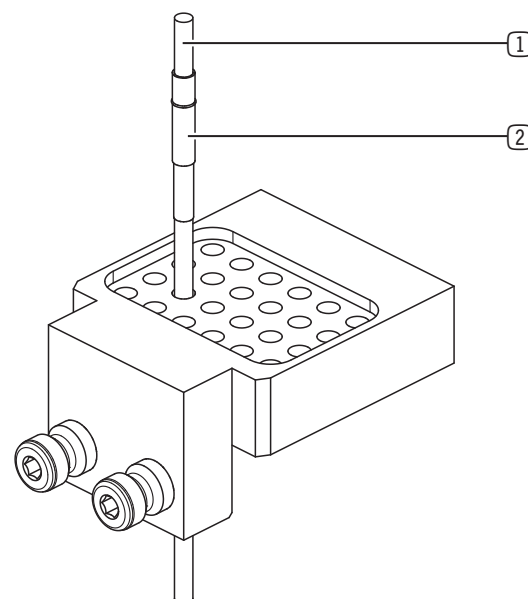
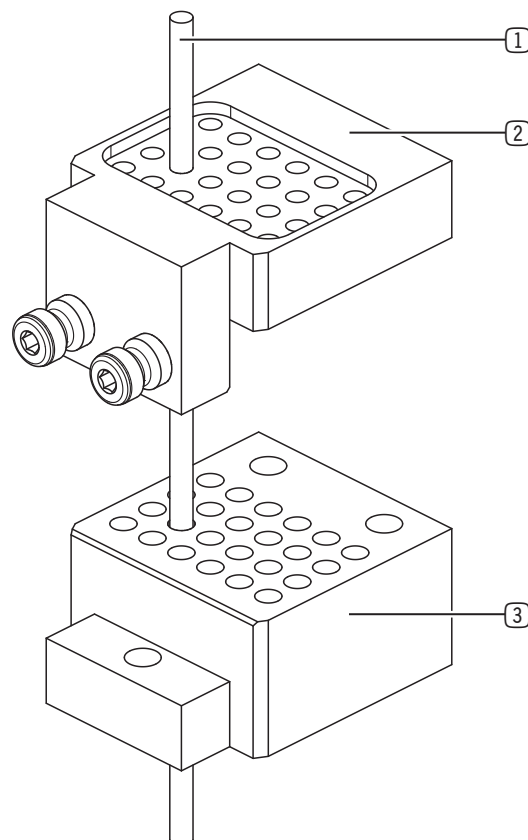
Everything is delivered pre-assembled except for the products WER1500FSlxx-05-A and WER1500LSlxx-05-A.

10.1 Pre-assembling the WER1500FSIxx-05-A

- Guide the cables through the cover and intake.

- ① cable
- ② Intake
- ③ Cover

- Strip the cables.
- Solder the cables with the sleeves.
- Push the sleeves back.
- Press the sleeves into the intake so they are flush with the surface.
 - Make sure that the tool used has a larger diameter than the sleeves.

- ② Sleeve

- ▶ Press the spring contacts into the sleeves.
- ▶ Hold the sleeves from below to stabilize them.

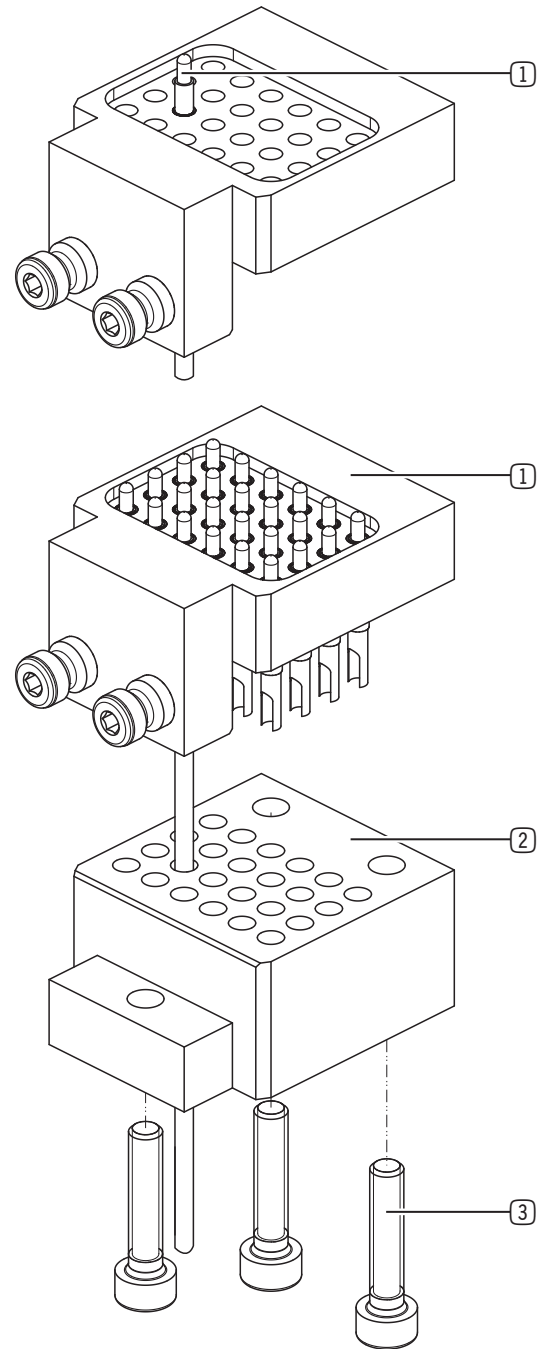
① Spring contacts

- ▶ Carefully pull the cables taut into the drilled holes on the cover.
- ▶ Slide the cover flush onto the intake.
- ▶ Make sure that the cables are not twisted or clamped.
- ▶ Mount the cover on the intake with the mounting screws.

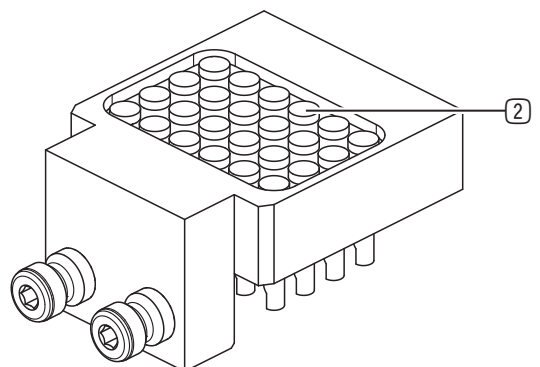
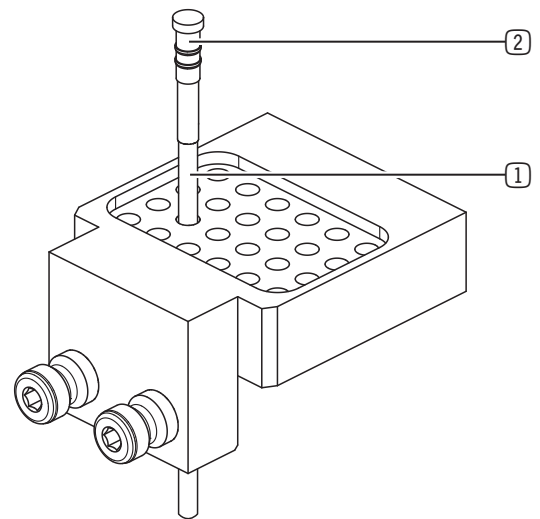
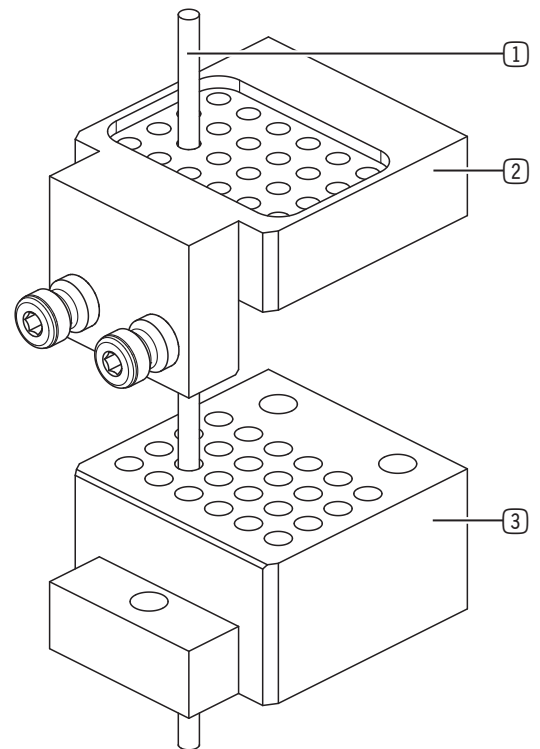
10.2 Pre-assembling the WER1500LSlxx-05-A

- Guide the cables through the cover and intake.

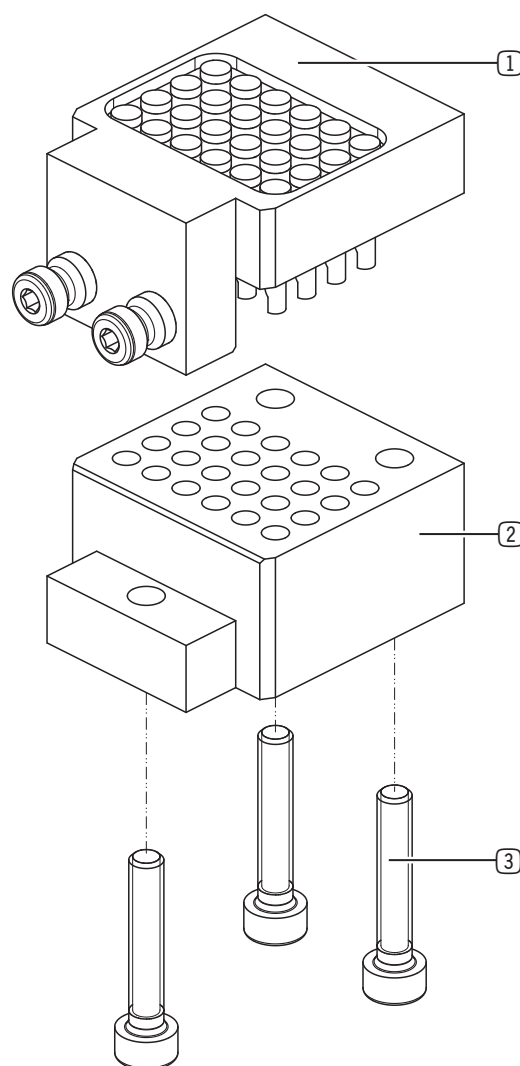

10.3 Installing the product on WPR5000

Material damage due to collision

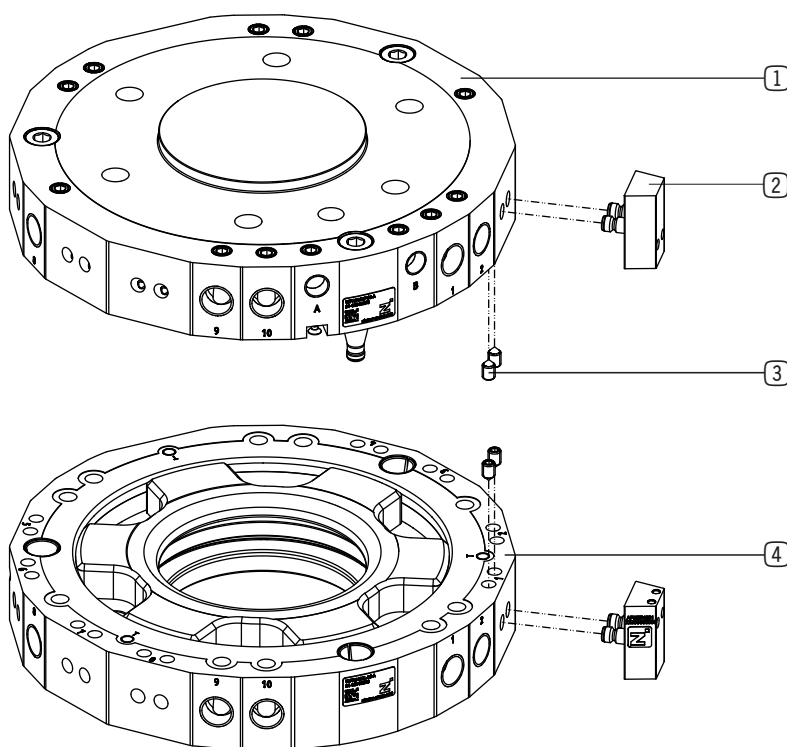
The use of adapter plates in combination with energy elements can result in interference contours that may cause interference, posing a risk of injury.

- Perform a collision check before commissioning.

Depending on the installation size of the tool changer, the products can be connected directly or via an adapter plate.

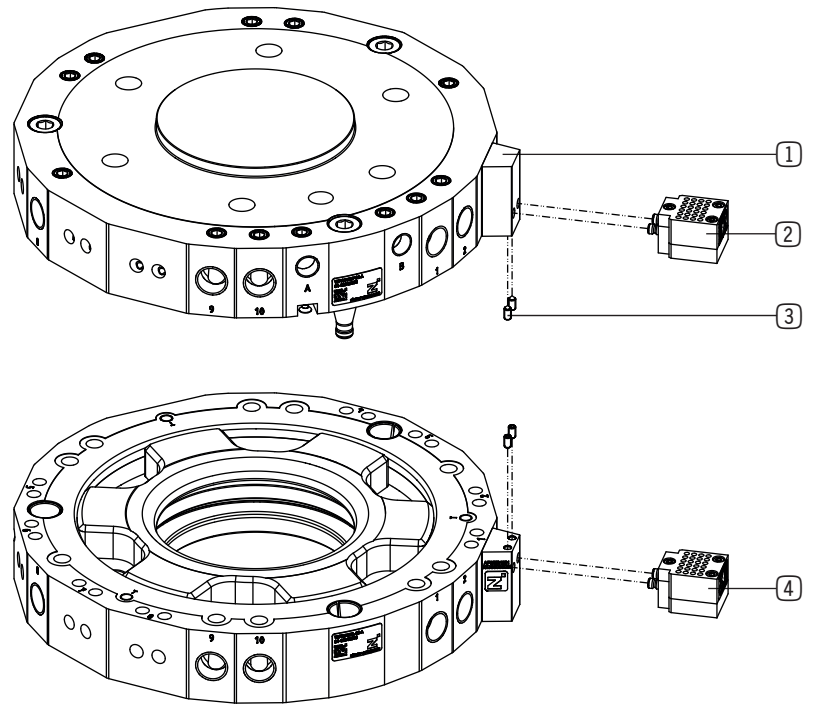

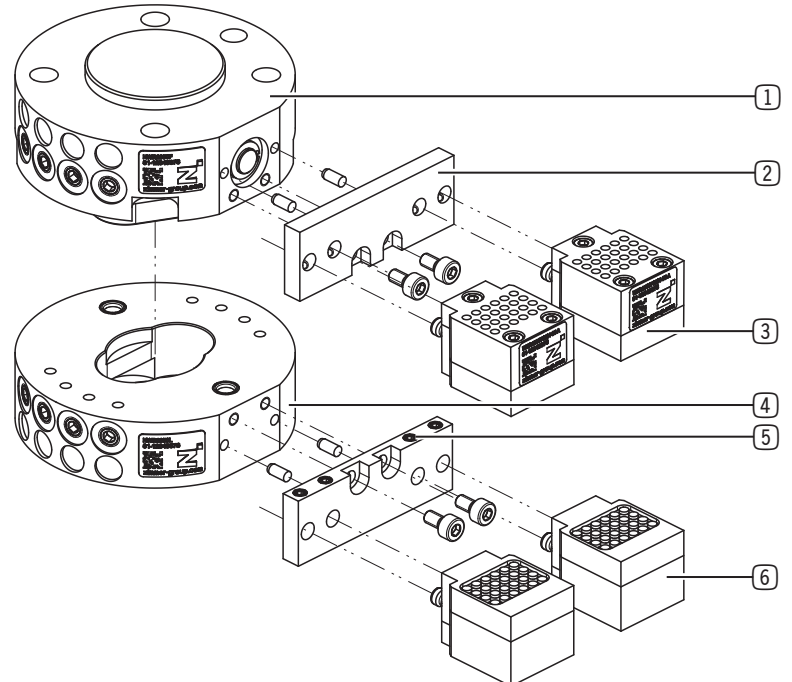

10.4 Installing the product on HWR and HWR2000

Adapter plates are required when installing on products of the HWR and HWR2000 series.

- Position the adapter plate on the tool changer with the straight pins.
- Mount the adapter plate on the tool changer by using the included mounting screws.
- Install the product via the pins.
- Use grub screws to secure the product.

10.5 Installing the energy supply

10.5.1 Electrical products

CAUTION



Risk of injury and material damage in case of non-compliance

Incorrect pin assignment can lead to malfunction or destruction of the product.

- Ensure the correct pin assignment for products with the hot-plug function.

NOTICE



Material damage and malfunction in case of non-compliance

The cable mounted on the product can be subjected to a torsional angle of +50°.

- Do not route the cable so that it is strained.
- You must meet the minimum bending radius of 10x the outer diameter.
- Secure free-hanging cables to prevent excessive motion loads or pinching.
- The contacts of the energy supply must be dry, clean and undamaged at all times.

- If necessary, install the energy supply for electrical products before installing the product on the tool changer.

- Connect the cables to the product using a round plug.

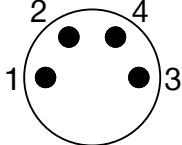

10.5.2 Pneumatic products

INFORMATION



- You can find the information about connecting threads on the technical data sheet on our website.

When they are coupled, pneumatic products seal using the pre-load of the seal. The pre-load is ensured by having the elements at a defined distance from each other.

- Connect the products to the power supply using connecting threads.
 - Make sure that the pressure class is correct when selecting suitable hoses.

10.6 Installing the protective elements

NOTICE

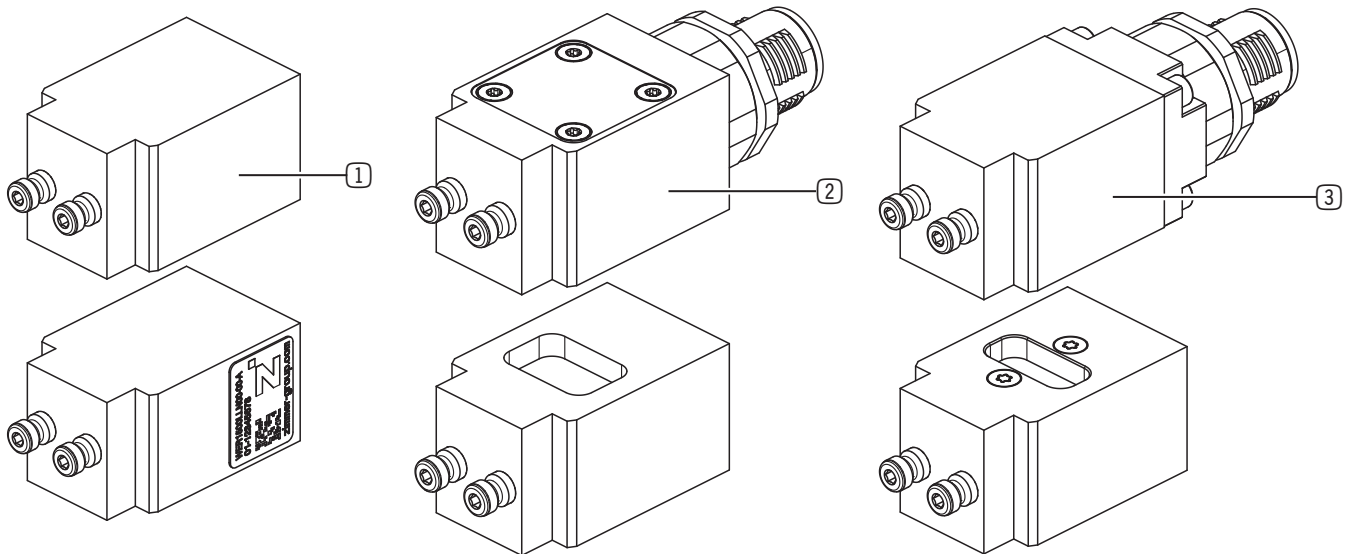


Non-compliance may result in material damage.

Expose the contacts and/or contact surfaces in the decoupled state. Protective elements are necessary to protect products that are temporarily not being used.

► While the products are uncoupled, protect them from dirt from the outside.

For electrical products, the side with the pocket for the contacts must point in the direction of the product to be protected.
For pneumatic products, the flat side must point in the direction of the element to be protected.

10.7 Installing the sensors

NOTICE



Non-compliance may result in material damage.

Cables must be installed with sufficient length.

► Ensure that the cables cannot be pinched, crushed, or torn off within the movement and swivel ranges.

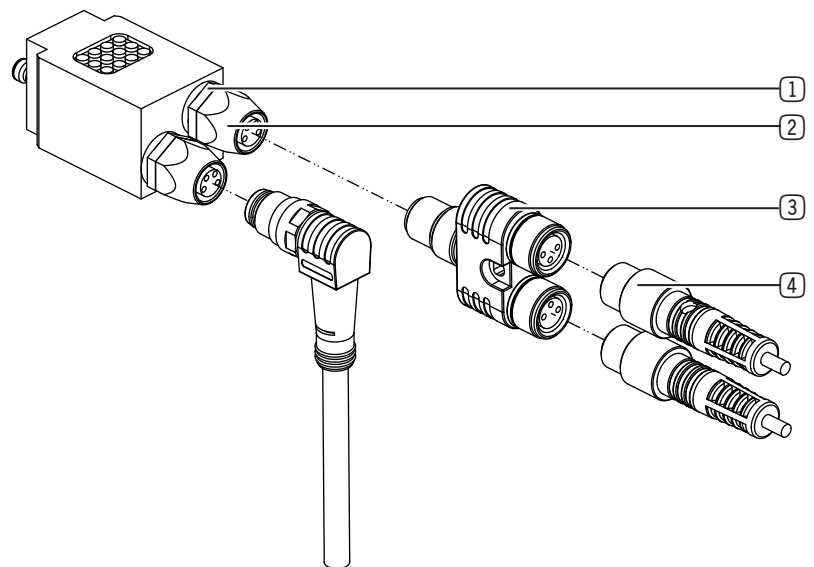
INFORMATION



Using a Y-distributor, you can connect two sensors.

The orientation of the round plug on the product can be changed.

- Loosen the lock nut.
- Turn the round plug to the desired position.
- Retighten the lock nut.
- Install the sensors.

11 Maintenance

NOTICE



Material damage resulting from blowing out with compressed air

Blowing out the product with compressed air can cause malfunctions.

- ▶ Never purge the product with compressed air.

NOTICE



Material damage caused by unsuitable cleaning materials

Seals, insulation, coatings and other surfaces may be damaged by solvent-based cleaning agents.

- ▶ Make sure that no liquids penetrate the product.
- ▶ Use chemically and biologically neutral cleaning agents.
- ▶ Use cleaning agents that are categorized as being nonhazardous to health.
- ▶ Use soft, lint-free cloths for cleaning the surface.

The use of the following cleaning agents is strictly prohibited:

- Acetone
- Cleaning solvent
- Nitrocellulose thinner/turpentine oil (solvents)

Material damage caused by sharp-edged tools

Hard scrubbers, brushes or blades can damage contacts and flat surfaces.

- ▶ Do not clean the product using any sharp-edged tools.

NOTICE



Non-compliance may result in material damage.

- ▶ Carry out regular leak tests on pneumatic products.
- ▶ Replace leaky component parts immediately.

Maintenance-free operation of the product is guaranteed for a specified number of cycles.

- ▶ Note that the product could become damaged under the following circumstances:
 - Operation with impermissible compressed air
 - Dirty environment
 - Improper use and use that does not comply with the performance data
 - Permissible temperature range not observed
- ▶ Even though the product is maintenance-free as mentioned above, perform a regular visual inspection to check for any damage or contamination.
- ▶ Have maintenance work that requires disassembly of the product performed by customer service only.
